Resolution 2023-21

A Resolution Revising Fees for Water and Sewer Department

WHEREAS; the McIntosh County Board of Commissioners is authorized, pursuant to Section 42-42 (3) of the McIntosh County Code of Ordinances to establish or revise, by resolution, fees to be charged to water and sewer customers,

WHEREAS; the McIntosh County Board of Commissioners deems it necessary to revise fees within the McIntosh County Water & Sewer Department in order to maintain the water and sewer system as well as plan for future growth,

NOW, THEREFORE BE IT RESOLVED by the McIntosh County Board of Commissioners that effective on November 1, 2023 the following schedule for water and sewer fees are hereby established and adopted:



Water Base Rate/Base Charge	\$37.50/5,000 gallons
Water Tiered Rate (5,001-10,000 gallons)	\$3.75/1,000 gallons above base rate
Water Tiered Rate (10,001 and above)	\$4.25/1,000 gallons above Tier 1
Water Deposit	\$100.00 per Account
Administrative Fee for New Acct.	\$15.00
Water New Meter Installation Fee (New Acct.)	\$350.00
Water Connection Fee (New Acct.)	\$600.00
Water Reconnect Fee	\$100.00
Water Late Charge	\$10.00
Sewer Base Rate (Business)	\$200.00

Sewer Base Rate (Hotel/Motel)	\$300.00
Sewer Tiered Rate	\$5.00/1,000 gallons
Sewer Connection Fee (New Acct.)	\$2,500.00
Sewer Reconnect Fee	\$100.00
Sewer Late Fee	\$25.00
Call-Out Fee	\$50.00
Call-Out Fee (After Hours)	\$75.00
