**February 3, 2025**

**MEETING CALLED TO ORDER:** David Gardner, Chairperson, called the meeting to order at 6:00 PM.

As of June 1<sup>st</sup>, Probate Judges will no longer act as Election Supervisors. Training for all 159 Election Supervisors and staff will be held on April 28<sup>th</sup>, 29<sup>th</sup> and 30<sup>th</sup>.

Voting equipment will be moved from its current storage location at the 911 call center, to the old youth detention center. The building is brick with security cameras and an exterior door.
