**REPORTS:**

**SUPERVISOR:** Currently working on building the November ballot. There are two City Council seats up for election in the Nov. 4 General Election. For the South Ward, Russ Quarterman is running unopposed. North Ward has three candidates, Mayor Pro Temp Griffith Lotson, Kevin Brown and Lori Patricia Daughtry. Also, on the ballot will be a TSPLOST and the Public Service Commissioner. The State sent roughly 500 names of people to be moved from inactive status to a canceled status on the voter registration rolls due to Georgia Code 21-2-234 and Georgia Code 21-2 -235. This is the result of a voter who has not had any contact with the election officials and has not voted in two consecutive federal general elections can be moved from inactive to canceled registration.

**ATTORNEY:** No update on the Sapelo Island case. Suggested the Board go into executive session. Chair Mrs. Fly made the motion to go into executive session, Ms. Stachur 2<sup>nd</sup>. Motion carried. Board went into executive session at 6:17pm. Motion to return to public meeting made by Ms. Thomas, Mr. Trexler 2<sup>nd</sup>, motion carried. The Board returned to public meeting at 6:37pm.

2. Develop policy regarding inclement weather

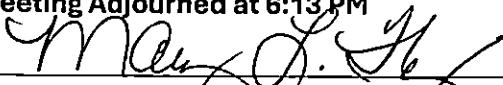
